TSNZ AGM

This is being held in Wellington, Saturday 27th October. Steve O'Donnell will be our representative at the meeting. The board of TSA has submitted the following remits for voting on by the representatives of all Associations in NZ at the meeting.

Auckland Remit 4: Indoor Rules

a) Current ruling:

2.9.3 Affiliated shooters shall compute their grading average out of 100 by adding all scores for the grading period as specified in rule 2.9.2, and dividing the result by the number of 10 shot targets involved. A minimum of six official scores shall be required for grading purposes. The shooters grading for the next season shall then be determined from the following grading table:

Master Grade 97.75 - 100

A Grade 96.50 - 97.74

B Grade 94.00 - 96.49

C Grade 90.00 - 93.99

D Grade 89.99 and under

b) Revised ruling:

2.9.3 Affiliated shooters shall compute their grading average out of 100 by adding all scores for the grading period as specified in rule 2.9.2, **excluding the lowest three (3) scores** and dividing the result by the number of 10 shot targets.

A minimum of six official scores shall be required for grading purposes. The shooters grading for the next season shall then be determined from the following grading table:

Master Grade 97.75 - 100

A Grade 96.50 - 97.74

B Grade 94.00 - 96.49

C Grade 90.00 - 93.99

D Grade 89.99 and under

c) Explanation:

Typically, the lowest scores are due to equipment malfunction, accidental shot release, ill health or eyesight issues. These scores are not representative of the shooters normal performance and should be excluded from their grading calculations.

Auckland Remit 1: Indoor Rules

a) Current Ruling:

- **2.8.1.7.1 TOO MANY SHOTS ON SIGHTING DIAGRAM** If the sighting diagram has more than the maximum of three permitted shots and:
- (i) The total number of shots, including sighting shots, is not more than 13 (100 possible) or 23 (200 possible), then the three highest valued shots on the sighting diagram shall be discounted and the remainder shall be treated as counting shots. A penalty deduction of one point for each excess shot fired on the sighting diagram shall be imposed.
- (ii) The total number of shots, including sighting shots, exceeds 13 (100 possible) or 23 (200 possible), then the three highest valued shots on the sighting diagram shall be discounted and the remainder shall be treated as counting shots and Rule 2.8.7.3 shall apply.

b) Revised ruling:

- **2.8.1.7.1 TOO FEW SHOTS ON SIGHTING DIAGRAM** A minimum of 2 sighting shots are to be fired with no maximum number. If the sighting diagram has less than the minimum 2:
 - (i) The minimum number of shots, including sighting shots, is 12 (100 possible) or 22 (200 possible). Should a completed target have only one sighting shot then the highest counting shot shall be regarded as a sighting shot and discounted. Should a completed

target have no sighting shots, then the two highest counting shots shall be regarded as sighting shots and discounted.

(ii) If the total number of counting shots exceeds 10 (100 possible) or 20 (200 possible), then the highest valued shot/s on the diagram shall be discounted and the remainder shall be treated as counting shots and Rule 2.8.1.7.3 shall apply.

Auckland Remit 3: Electronic Targets

Current Ruling:

2.8.2.4.1 TOO MANY SIGHTING SHOTS – if there are more than the maximum of three permitted sighting shots on a completed match printout and i) the total number of shots, including sighting shots, is not more than 13 (100 possible) or 23 (200 possible), then the three highest valued shots on the sighting diagram shall be discounted and the remainder shall be treated as counting shots. A penalty deduction of one point for each excess shot fired on the sighting diagram shall be imposed. ii) the total number of shots, including sighting shots, exceeds 13 (100 possible) or 23 (200 possible), then the three highest valued shots on the sighting diagram shall be discounted and the remainder shall be treated as counting shots and Rule 2.8.1.7.3 shall apply. **2.8.2.4.2 TOO FEW SIGHTING SHOTS** – Should a completed match printout have i) only one sighting shot then the highest counting shot shall be regarded as a sighting shot and discounted. ii) no sighting shots, then the two highest counting shots shall be regarded as sighting shots and discounted. Failure to notify the Range Officer before commencing counting shots will deem the shooter to have fired the number of sighting shots that appear on the match printout.

Revised Ruling:

2.8.2.4.2 TOO FEW SIGHTING SHOTS (to be renumbered **2.8.2.4.1**) – Should a completed match printout have i) only one sighting shot then the highest counting shot shall be regarded as a sighting shot and discounted. ii) no sighting shots, then the two highest counting shots shall be regarded as sighting shots and discounted. Failure to notify the Range Officer before commencing counting shots will deem the shooter to have fired the number of sighting shots that appear on the match printout.

As there is no requirement for 2.8.2.4.1 rule 2.8.2.4.2 is to be renumbered 2.8.2.4.1

c) Explanation:

The current procedure of firing sighting shots is to fire a minimum of 2 with an optional 3rd. When shooters are involved in the BSA Indoor Postal Competition, Commonwealth Cities Match, North Island V's Scotland Match, NZ Indoor Rep Matches (at the conclusion of the North V's South Island Indoor event) or 50m Outdoor matches, the format of unlimited sighting shots is applied. For consistency, the unlimited sighting shots option should be applied to all indoor shooting. This amendment also applies to 2.8.2.4.1 and 2.8.2.4.2 (electronic targets).



Auckland Remit 2: Indoor Rules

Current Ruling Rule 2.11.9 SIGHTING SHOTS (Indoor Rules)

2.11.9.1 two compulsory sighting shots and one additional sighting shot shall be permitted on the designated sighting diagram, prior to the commencement of counting shots (see Rule 2.8.1.7.2)

Revised Ruling:

Rule 2.11.9.1 A minimum of two compulsory sighting shots shall be permitted on the designated sighting diagram, prior to the commencement of counting shots (see Rule 2.8.1.7.2). There is no maximum number of sighting shots.

Explanation:

This amendment is connected to Remit 1 allowing for unlimited sighting shots prior to the commencement of counting shots.

All the proposed remits for the meeting along with the financials of TSNZ are able to be viewed on the TSNZ website. The outcome of the above remits will be advised when available.
